I became a part of the ATA family during the 2017-2018 academic school year. In my role as a School Social, I aim to help bridge the gap between home, school and community to help students be as successful as possible.

In my role as a School Social Worker, I assist parents, students and school staff to identify the needs that interfere with learning. I also provide in- school services to general students who may have difficulty maintaining a mental illness or to those who may need help to resolve social, emotional, and behavior problems. This is done through consultations with family, school staff and sometimes community providers, through development and by implementation of behavior management plans.

I provide a safe place for students to share their feelings that can sometimes involve peer pressure, trauma, anxiety and depression. My goal is to equip students with tools necessary to help them cope. However, if need be, this resource manual will be used to link students and or families to community resources that may be of more assistance to them. This manual will also serve as an alternative to connect families to resources based on other personal individual needs that may include finances, transportation, health care or employment.

Dear Parent/Guardian,

Greetings and wishes for a healthy and productive year! As both a registered nurse (RN) and a certified teacher, I have the opportunity to serve the ATA community in a special way. I am proud to serve as ATA's on-campus District Nurse to assist with student, family and staff health-related needs. Your child is one of the few in Michigan who has the benefit of having an RN on campus on a regular basis.

Having an RN on campus contributes to optimizing the management of chronic conditions and routine health promotion. As an RN, I can coordinate care with your child's pediatrician so that proactive measures can be implemented to lessen absences, promote wellness, and foster success. Coordination can lead to the formation of an individual school-based health care plans (IHP) to outline appropriate interventions and provide guidelines so that signs of health emergencies can be identified and addressed quickly. In addition to crisis management, having an RN on campus provides easy access to professional guidance, judgment, insight, and resources for health-related needs, questions or concerns.

Following the National Association of School Nurses (NASN)'s 21st Century Nursing Practice framework, health-related services and support are implemented with the assertion that "Healthy Children Learn Better." In addition to providing nursing assessments, implementing physician-driven orders to develop IHPs to promote holistic success, managing vaccination compliance and participating in interdisciplinary collaboration, I strive to create health promotion awareness in students and their families. This involves providing education about community health issues, illness prevention and life-long success.

Although I am routinely on campus, I rely on the support of a special group of designated staff volunteers that make up ATA's Medical Emergency Response Team (MERT). These members are delegated specific tasks to assist with interventions in health-related emergencies at school and support student health during the school day. The MERT helps optimize student support through the minimization of disruptions in learning, coordination of care and the formation of health-promoting routines under my leadership as District Nurse.

Families are encouraged to have ongoing preventive and wellness relationships with family. However, if you do have questions about urgent health matters or need guidance of where you may obtain services or support, please feel free to contact me any time. I encourage you to visit the ATA Nursing Website regularly to find useful information about vaccinations, wellness promotion, obtaining health care services, providing appropriate documentation for IHPs and/or medication to be at school, and more! I am extremely honored to serve the ATA community in this special way and look forward to working with you in fostering holistic success for your child!

Description: *WIOA Youth programs assist young adults to become effective leaders in the community.* The programs aim to remove barriers that may prohibit youths from achieving their social, academic and professional goals.

At-risk high school students transition in and out of school by learning how to create an environment that builds positive relationships, provides an innovative curriculum, fosters personal discovery, increases self-esteem, and emphasizes the importance of cooperation, which leads to high school completion. WIOA Youth programs aim to ensure youths are given the necessary tools they need to succeed and have the knowledge needed to secure employment opportunities. Youth programs include:

- Tutoring, study skills, instruction leading to secondary school completion, including drop-out prevention strategies
- Connection to employment opportunities: Students are offered opportunities for subsidized employment; other students will be referred to unsubsidized employment opportunities generated by program staff
- Leadership development opportunities: Youth can participate in leadership conferences and volunteer community service opportunities.

Eligibility: Youth between the ages of 16 and 21 who are considered low income, deficient in basic literacy skills, high school drop-out, homeless or runaway, foster child, criminal offender, or any individual who requires additional assistance because of a disability.

Each guest is granted a designated number of pounds of food, based on family size. Non-perishable items and frozen meats are included in the allotted pounds; but fresh vegetables, dairy items, bread and other perishable foods are not. Those items are available to consumers over and above their weight total.
